## Setup Fee - No Cost

## **Monthly Fees**

A monthly licence fee of AUD \$132.00 (\$77.00 for Platform Users) is charged on the 1st of each month in advance. Associated offices are charged an additional \$22.00 per month

This is due and payable by the 25th of the following month

Each SMS that is sent to your subscribers is charged at 0.05 cents per SMS

This amount is totalled and added to your monthly account and charged in arrears. Accounts are due and payable by the 25th of each following month
